Being first duly sworn, I hereby depose and state as follows:


1. My name is Lawrence Peter Baumann. I am a resident of Northampton County, Virginia,

 - b. I cut to the chase, and I asked her whom she was calling for. She told me she was calling for Webb.
 - c. I told her not to worry about me, that I would be voting for Webb.
 - d. She then asked what time I was going to vote, and I told her it would be before work.
 - e. She then told me that I would be voting at West Reed Street.
 - f. I told her that there was no street by that name and that if she was supposed to be helping Webb she needed to give correct information.
 - g. She said, oh gee, my mistake or some similar type of comment. She never gave me the correct precinct and never offered to get back to me with my correct precinct.
 - h. I asked her where she was calling from and to the best of my memory, she stated California.

"This message is for Timothy Daly.

"This is the Virginia Elections Commission. We've determined you are registered in New York to vote. Therefore, you will not be allowed to cast your vote on Tuesday.

"If you do show up, you will be charged criminally."

3. I have not voted in New York since before I moved to Arlington, Virginia.

4. I am lawfully registered to vote in Arlington County, Virginia, where I reside and I am deeply disturbed by this threat seeking to intimidate me from voting.
